- I. Call to Order was promptly 10:00am

- III. 2024-2025 Senate Introductions
 - a. The present senators introduced themselves and shared which division they represent, along with their role at the university.

IV. Overview of the Staff Senate

- a. Taylor Haigler reviewed the mission statement and vision statement of the Staff Senate with the group. She expressed that the new senate term brings opportunities to build a strong and sustainable organizational foundation for the senate to grow on. She reviewed the newly implemented strategic goals of the Staff Senate and shared that all initiatives will tie to a strategic goal to align with our purpose and support the university's vision.
- b. Taylor Haigler reviewed the organizational structure of the Staff Senate, explaining how senate seats are designated and the role of a senator. She explained the board positions, including Chair, Chair-Elect, Secretary, and Treasurer. She discussed the roles of the five senate committees and encouraged the senators to think of what committee they would like to serve on. Committee assignments and the elections for Chair-Elect, Secretary, and Treasurer will be at the August Staff Senate meeting.
- c. The senate discussed goals and priorities for the 2024-2025 term. Taylor Haigler emphasized her focus on establishing clear policies and guidelines for the senate, potentially in the form of bylaw updates, a senator code of conduct, or a senator handbook. Karla Coffey suggested implementing an employee garden on campus and shared her involvement with the garden student group on campus that could lead to a future partnership. Awaili Thomas-Quarles emphasized her focus on mental health support for the university's staff, faculty, and students.

V. Election of Senate Chair

- a. Matt Moore facilitated a Special Election for the Senate Chair by secret ballot. Awaili Thomas-Quarles and Taylor Haigler accepted nominations for Senate Chair. There was not a majority vote during the meeting. Matt Moore will contact the four absent senators for their vote and will report back to the senate when the results are conclusive or by July 15th, whichever comes first.
- VI. Discussion on Senate Vacancies

Staff Senate Mission Statement

Matt Moore noted that we will need to consider the division that will have a vacancy once the chair is elected.
